

**ESCALANTE CITY
ORDINANCE 2020-08**

**AN ORDINANCE AMENDING ESCALANTE CITY CODE NO.10.02.140 AND
10.02.150 AND PROVIDING REPEALER WITHIN THE CITY OF ESCALANTE,
STATE OF UTAH.**

WHEREAS, The City Council, as governing body of the City of Escalante, State of Utah, specifically find it in the best interest of the safety and welfare of the citizens of the City of Escalante to amend Escalante City Ordinance 10.02.140 and 10.02.150.

NOW THEREFORE, be it ordained by the Council of Escalante City, in the State of Utah, as follows:

SECTION 1: **AMENDMENT** “10.02.140 Amendments” of the Escalante Zoning Code is hereby *amended* as follows:

A M E N D M E N T

10.02.140 Amendments

Escalante City may from time to time amend the number, shape, boundaries or areas of any district, or regulation, or other provision of the Zoning Ordinance, but any such amendment shall not be made or become effective until after ~~ten~~**fourteen (10+4)** days notice and public hearing and unless the same shall have been proposed by or be first submitted to Escalante City Planning Commission for its recommendation, which shall be returned within (30) days.

SECTION 2: **AMENDMENT** “10.02.150 Hearing And Publication And Notice Before Amendment” of the Escalante Zoning Code is hereby *amended* as follows:

A M E N D M E N T

10.02.150 Hearing And Publication And Notice Before Amendment

Before finally adopting any such amendment, Escalante City ~~Planning and Zoning Council~~ shall hold a public hearing thereon, at least ~~ten~~**fourteen (10+4)** days notice of the time and place of which shall be given by at least one (1) publication in a newspaper of general circulation in Escalante City.
